## **BOARDING AGREEMENT (Dogs & Cats)**

**Kennel agrees to exercise and provide due and reasonable care to board the Pet for the Owner.** Kennel does not assume and shall not be held responsible for any liability with respect to the Pet listed in the agreement, for any liability arising out of or from the boarding of this Pet, or any damages which may occur for any other cause whatsoever, including loss by fire, theft, running away, injury to persons, animals or property, unavoidable causes, or death or injury to any other animal caused by, within named Pet during the term of this contract, whether this Pet be on the premises of the Kennel or not. Owner hereby agrees to be and is solely responsible for any and all behavior of said Pet at any time within the term and time for the contract. \_\_\_\_\_ (initial)

**\*Food is to be provided by owner for the duration of the pet's stay with LEVS. If food is not provided an in-house diet will be provided at additional cost to the owner. \*** \_\_\_\_\_ (initial)

**All vaccines must have been administered by a licensed veterinarian or through a veterinary clinic.** Pets may have the exams and vaccines completed by Leading Edge Veterinary Services (LEVS), or the client must present written proof of current vaccinations for each pet boarding prior to the stay. \_\_\_\_\_ (initial)

**LEVS strives to maintain a flea and tick free environment.** Please provide the name and date of last application of your flea/tick preventative. If your pet is inadequately protected, LEVS reserves the right to treat pets at owner's expense. \_\_\_\_\_ (initial)

Although obviously sick or unvaccinated pets are not permitted to receive boarding and grooming services, the client acknowledges that they are placing the pets in an area in which communicable diseases may pass between seemingly healthy pets. If following a provided service date the pet shows signs of illness, the client may not hold LEVS liable for any inadvertent exposure the pet may have received, and that if the client requests an exam, treatment, or medications for the pet, these will be provided at full cost to the client. \_\_\_\_\_ (initial)

**LEVS will allow personal items to remain with the pets.** LEVS will do our best to return items in the same condition that they were left with us, BUT NO GUARANTEE CAN BE MADE AGAINST LOSS OR DAMAGE. \_\_\_\_\_ (initial).

**In the event your pet, while in our care, develops an illness or health concern,** every attempt will be made to contact you or a designated emergency contact that you have provided for us. If we are unable to reach you, we will provide appropriate medical care and additional fees will be applied to your account. \_\_\_\_\_ (initial)

**In case a LIFE-THREATENING EMERGENCY arises with your pet and we are unable to reach you: \*MUST CHECK ONE\***

I understand LEVS will make every reasonable attempt to contact me at the emergency numbers provided. I agree to pay all charges associated with medical services to my pet.

If you neglect to pick up your pet within 7 days of the pick-up date, LEVS may assume the pet(s) is abandoned and is authorized to relinquish or humanely dispose of the pet(s) as they deem necessary.
